The Junior League of Westchester on the Sound Awards Largest Grant In Its History

The Junior League of Westchester on the Sound (JLWOS) celebrated its 75th anniversary on October 9 with a lively event at Locals 10538 in Larchmont, attended by its members, representatives of its community partners, and several local elected officials. In recognition of the significance of the 75th anniversary milestone, JLWOS President Chris Howe announced a Transformational Grant of \$100,000 to Meals on Main Street of Port Chester, a nonprofit organization addressing hunger and food insecurity for New Yorkers across the Sound Shore. This is the largest single grant in the history of the JLWOS.

Over the years, JLWOS has played an important role in catalyzing community organizations and services like Furniture Sharehouse, the Youth Employment Service at Mamaroneck High School, and LMC Media, among others. JLWOS also has a strong tradition of providing grants to community organizations, having disbursed an estimated \$1 million since its inception to a wide range of nonprofits across Sound Shore neighborhoods. In its 75th anniversary year, JLWOS launched the ambitious Transformational Grant initiative to spark innovative and

high-impact initiatives intended to bring about significant and lasting positive change.

JLWOS' Transformational Grant will fund the launch of Meals on Main Street's innovative Mobile Community Café, a first-of-its-kind sit-down dining experience featuring a menu with no prices. The Mobile Community Café will traverse the Sound Shore in collaboration with community

partners like Hope Community Services in New Rochelle to be accessible in convenient locations for its target clients. In its first year of operations, the Mobile Community Café is expected to provide 50,000 meals, to connect 25 percent of people served with local support services, and to serve as a showcase for other communities in Westchester County and beyond.

"We are thrilled to support the launch of the Mobile Community Café, at a time when food insecurity is on the rise, and we are excited about

its new model to provide high-quality meals with dignity where they are most needed," said JLWOS President Chris Howe.

"Innovation in the fight against hunger and food insecurity is not just about creating new solutions, it's about reimagining how we bring nourishment directly to the people who need it the most, with dignity, speed, and care," said Meals on Main

Top Honors: Dr. Nicholas Cicchetti, Hawthorne


Dr. Nicholas Cicchetti has dedicated

Families of the Fallen Honored at Gold Star Mothers Ceremony



Westchester County Executive Ken Jenkins and Veterans Service Agency Director Josh Gaccione led a solemn ceremony last month, paying respects to the parents and families of those who died in military service.

The County's Annual Gold Star Mothers and Families Tribute Ceremony took place at the Kensico Dam Plaza Walk of Honor, where county service members lost during Operations Iraqi Freedom and Enduring Freedom are memorialized. They were saluted at the ceremony by members of Bronx Army Recruiting Company and New York City Recruiting Battalion as their names were read.

The tradition of wearing a gold star to signify a family member loss in service goes back to World War I. In 1936, Congress designated the last Sunday in September as Gold Star Mother's Day, now known as Gold Star Mother's and Families Day. After World War II, the Gold Star Lapel Pin was designated by Congress to be given to immediate family members of active-duty military killed in service.

County Executive Ken Jenkins said: "When a child is called to military service, for parents there's pride, there's patriotism, but there's trepidation too, because military parents share a fundamental dream -- that their child will come home. No one dreams of a Gold Star. To our Gold Star mothers, fathers and families, we are in awe of you. Our respect for your strength is deep. Our empathy for your loss is boundless. Our commitment to you is total, and our resolve to keep your child's memory alive is absolute Their spark of life may be gone from the plane, but we know still burns in you. May it burn in us too."

Westchester County Executive Ken Jenkins and Veterans Service Agency Director Josh Gaccione: "There's no human loss more profound than the loss of one's child There are many sacrifices in military life, but for the mothers and fathers of our fallen heroes, that sacrifice is enduring. It is a testament to their strength and grace that they too endure. We can't replace what they've lost, but we can resolve every day to fill the hole left behind with our strength, support and love."

ety of Yonkers Guardianship Program became a critical safeguard for Westchester's most vulnerable elderly residents, such as those who are incapacitated and at risk of abuse, neglect, or exploitation. Since its inception, the program has protected over 2,000 seniors. Frankel also launched a Kinship Support Program, helping grandparents and other relatives provide safe, nurturing homes for children in their care. In addition, Frankel developed the Homestead Program, which provides safe, stable housing for homeless elderly and disabled residents of Westchester.

Distinguished Honoree: Janice King Griffith, White Plains

Janice King Griffith has provided transformative leadership in Westchester County as a civil rights advocate, community leader, and volunteer. As President of the White Plains/Greenburgh NAACP Branch, she has worked tirelessly with elected officials, institutions, and grassroots groups to advance racial justice. Her innovative leadership of the White Plains Police Reform Committee produced some of the strongest reform recommendations in New York State, many of which have already been implemented. Through her NAACP leadership and committee roles, Griffith has worked to build stronger, safer, and more inclusive communities where seniors can thrive.

Distinguished Honoree: Colette Phipps, New Rochelle

Colette Phipps is the Executive Director of Livable Communities, A Vision for All Ages, an umbrella initiative that has provided and promoted awareness, discussion, and action through programming meant to improve quality of life in the Westchester community. Programming

developed under Ms. Phipps' leadership includes, Westchester's Livable Communities Initiative with six contracted regional coordinators strategically located throughout the country to deliver hyperlocal, targeted services, Caregiver Coaching and other caregiver support programs, Telehealth Intervention Programs for Seniors (TIPS), Health for Life, The Chronic Disease Self-Management Program, The Village Approach, The Speaker's Bureau, and work with the aging network through specialized collaboratives. Under Ms. Phipps' leadership and direction, Westchester became a member of AARP's Network of Age-Friendly Communities and the Global Network of Age-Friendly Cities and Communities of the United Nation's World Health Organization, paving the way for the county to be designated an Age-Friendly place. Ms. Phipps serves on several boards, she is a New York Academy of Medicine Fellow and an adjunct professor at Fordham University Graduate School of Social Service. Ms. Phipps is the current President of the State Society on Aging of New York.

New Law to Equip County Police Officers with Epipens for Allergy Emergencies

Standing alongside Westchester County Police Officers, Westchester County Executive Ken Jenkins recently signed into law legislation that will ensure relevant County Police officers are equipped and trained to administer epinephrine auto-injectors (EpiPens) while on duty—providing a critical, life-saving tool for allergy emergencies.

Jenkins said: "By signing this bill into law, Westchester County is taking a major step forward in protecting our residents and giving our officers the tools they need to save lives. This legislation is about preparedness, compassion, and ensuring that no family has to experience a preventable tragedy."

Board Chairman Vedat Gashi said: "When a constituent reached out asking us to help families struggling with potentially life-threatening allergic reactions, I knew Westchester needed to do everything it could. Too many families, including my own, live with the daily fear of a severe allergic reaction, and this law will help ensure that first responders are ready to save lives. I'm proud that the entire Board voted to make this commonsense step a reality."

The new law—known as the Giovanni Cipriano Act—provides that all relevant County police officers carry EpiPens. Named in memory of Giovanni "Gio" Cipriano, a 14-year-old New Yorker who tragically died after unknowingly consuming peanuts in trail mix, the legislation ensures officers—often the first on scene during 911 calls—can respond immediately to cases of anaphylaxis, a severe and potentially fatal allergic reaction.

The Love for Giovanni Foundation Founder Georgina Cornago said: "To see Gio's Law come to life here in Westchester County is deeply emotional and inspiring. This law will ensure that officers are trained and ready to act when seconds matter most. My son Giovanni's legacy continues to save lives, and I'm profoundly grateful to County Executive Ken Jenkins, Legislator Vedat Gashi, and everyone who helped make this happen."

Westchester County Department of Public Safety Chief of Police James Luciano said: "This initiative is a tremendous step forward in protecting the lives of our residents and visitors. In cases of anaphylaxis, every second counts. By equipping our officers with EpiPens, we're ensuring they have one more lifesaving tool to use in those critical moments before medical personnel arrive. This new law reflects the strong partnership between our County leadership and the Department in advancing public safety."



Majority Whip Terry Clements Chair of the Board's Public Safety Committee said: "This is a simple, life-saving measure. Giving our officers epinephrine auto-injectors means they can act fast and protect residents when it matters most."

Legislator Colin D. Smith Chair of the Board's Legislation Committee said: "We have heard heartbreaking stories, including the tragic deaths of children, due to the lack of immediate access to life-saving treatment. This Act takes a crucial step forward by ensuring our officers have both the tools and training to respond in those critical moments. I am proud to support legislation that will help prevent these tragedies in our community."

Legislator Nancy E. Barr Chair of the Board's Human Services Committee said: "For an individual experiencing a life-threatening allergic reaction, the quick administration of epinephrine is a matter of life and death, so training and supplying our County public safety officers with epinephrine auto-injectors is sure to save lives. I hope that the passage of this law at the County level will encourage all of Westchester's cities, towns and villages to adopt a similar law in their local municipality if they have not already done so."

Westchester County Office for Women Provides Cell Phones to High-Risk Clients in Partnership with T-Mobile

In recognition of October as Domestic Violence Awareness Month, the Westchester County Office for Women (OFW), under the leadership of County Executive Ken Jenkins and with the support of the Westchester County Board of Legislators, obtained 100 cell phones for high-risk clients served by the Office for Women.

The phones were donated through a partnership with T-Mobile for OFW clients who are victims of domestic violence in high-risk situations. For victims, access to a clean, safe and reliable phone can be a lifeline in emergencies — allowing them to call 911, contact advocates, and connect with critical services without fear of being monitored or cut off.

Jenkins said: "Domestic Violence Awareness Month reminds us that too many of our neighbors live with fear and danger every day. These phones are more than just devices — they are a tool for safety, protection, and empowerment. This initiative ensures that victims of domestic violence have a reliable way to seek help when they need it most."

Westchester County Office for Women Director Robi Schlaff said: "For our high-risk clients, safety planning often begins with access to reliable communication. This initiative highlights the County's commitment to protecting and empowering survivors, not just in October but all year long. We express our gratitude to T-Mobile for working closely with the Office for Women to make it possible."







Why Safe Deposit Boxes May be Creating More Problems Than Protections

For generations, families relied on bank safe deposit boxes to safeguard important documents, jewelry, and sentimental heirlooms. Having a key to a safe deposit box once symbolized prudence and financial responsibility. But in today's world of digital records, cloud storage, and home safes, these boxes are not only outdated but they can create serious legal and practical challenges, especially after a death. Understanding how safe deposit boxes work, and how access is handled when an owner or co-owner dies, can prevent costly delays and emotional frustration for loved ones.

When a person who rents a safe deposit box dies, the box and its contents are typically sealed by the bank. Financial institutions do this to protect themselves from liability and to ensure that only an authorized person, usually the executor or administrator of the estate, can access the contents. The problem is that the executor often cannot be appointed until the Will is submitted to the Surrogate's Court for probate, and the original Will is often inside the box. This circular dilemma can delay probate for weeks or months.

In New York the Estates, Powers and Trusts Law (EPTL) allows limited access to a decedent's safe deposit box for specific purposes, such as retrieving a Will, burial instructions, or a life insurance policy. However, the bank must follow a prescribed procedure and require proper identification and usually a court order before opening the box. The process takes time, particularly if the family is unaware that the box exists or cannot locate the key.

Many people assume that naming a joint owner on a safe deposit box will avoid these problems. Unfortunately, that is not always the case. A "joint tenant" has full access during both parties' lifetimes, but

once one owner dies, banks often restrict access until proof of death and estate documentation are provided.

This happens because the contents of the box may not actually belong to the surviving joint owner, even if their name appears on the box. The legal question becomes one of ownership: were the contents jointly owned, or did the deceased simply grant access for convenience? In some cases, the court appointed executor must provide a full inventory of the contents before removing anything, to prevent misappropriation of estate assets.

Beyond the access issues, safe deposit boxes themselves are quietly disappearing. Many major banks no longer offer them at new branches, and some have stopped renting them altogether. Maintaining secure vaults is expensive and labor-intensive, and today's consumers increasingly prefer digital or in-home alternatives.

Many of the reasons people once used safe deposit boxes, including storing original deeds, stock certificates, savings bonds, or important legal documents, no longer apply. Most records are now maintained electronically or can be easily replaced. What cannot be replaced is your original estate-planning documents which should be kept somewhere immediately accessible to your fiduciaries, not behind a locked door in a bank vault.

Branch consolidations also pose a risk. As banks close or merge, box holders may be notified that their branch is shutting down and must remove their contents by a deadline. If the notice is missed or goes to an old address, the contents can end up in the state's unclaimed property system, creating another layer of complexity for heirs.

For most people, a well-secured home safe offers a more practical and accessible option. Fireproof and waterproof safes rated for at least one hour of fire resistance can protect critical papers and valuables. Originals of your last will and testament, power of attorney, health care proxy and any trusts should be stored there, while your attorney should maintain copies.

It's also wise to maintain a written inventory of what's in the safe, share its location with your executor or trusted family member, and ensure that someone knows the combination or where to find it in

the event of an emergency.

Digital storage is another alternative. Many law firms now provide secure client portals, and reputable online vaults offer encrypted storage for scanned copies of legal documents, insurance policies, and passwords. However, digital storage should supplement, not replace, properly executed original documents.

Safe deposit boxes once represented the height of security and orderliness, but in modern estate administration they often cause the opposite: inaccessibility, delay, and confusion. Families can avoid these complications by understanding how banks handle access at death, reconsidering whether a box is necessary, and ensuring that essential documents remain easily accessible

to those who will need them most. By modernizing how you store and safeguard your important papers, you can give your loved ones the true peace of mind that safe deposit boxes were once meant to provide.

Table Hopping with Morris Gut -- Osteria Sardegna Premiers in Mamaroneck

I was driving up Halstead Ave. in Mamaroneck when I noticed the lights on at a new spot called Osteria Sardegna. It turns out to be a second coming for veteran restaurateur Vittorio Scarpa and his family who had operated a restaurant featuring the rustic dishes of Sardinia back in 2007 in Larchmont.

He has taken over the space once occupied by Padre Pio. A quick look inside and it is a charmer, filled with the art and artifacts of his native island off the coast of Italy's west coast. Scarpa, who came from a family of cooks, started in the food service business at his family's restaurants in Sardinia and Rome, then came to the States in the 80s and has been involved in the field in Los Angeles and New York City.

The 40-seat dining room is lined with lovely photos and prints of his native Sardinia. According to Scarpa, the roots of Sardinian cuisine come from fresh ingredients, nothing frozen. Sardinians are very proud of their fresh fish from the Mediterranean, roast pig, homemade breads, milk and cheese from goats, sheep and cows, and homegrown fruits, vegetables and herbs, garlic being of primary importance.

The opening menu offers such great starters as Pane Carasau, thin, flat and crispy Sardinian bread with mozzarella cheese, rosemary and olive oil; Bombas alla Sarda, meatballs, Sardinian style with tomato sauce and pecorino cheese; Arancini Quattro Formaggi, arborio rice, ricotta cheese, Sardinian pecorino, mozzarella and parmesan; Involtini di Melanzane, eggplant and ricotta, pecorino in tomato sauce; Arugula Salad with pears and gorgonzola in

a lemon dressing; traditional Caesar Salad, and Calamari Fritti.

Robust pasta specialties include Malloreddus, Sardinian style pasta with beef ragu; Culingiones, ravioli stuffed with pecorino, ricotta, garlic and basil sauce; Spaghetti Cacio e Pepe; Orecchiette Rapini, pasta with sausage and broccoli rabe, garlic & olive oil; and Linguine with eggplant and burrata cheese in tomato sauce.

Hearty main courses include Chicken Scarpariello, boneless with sausage, cherry peppers, served with penne, tomato sauce; Branzino alla Vermentino, sauteed with Sardinian white wine served with sauteed vegetables; Bistecca alla Sarda, grilled steak with broccoli rabe and roasted potatoes; Pork Chop Agrodolce Sardinian Style, double cut pork chop with vinegar peppers, rosemary and assorted vegetables; and Chicken Milanese. Breaded with an arugula chopped salad, olives, mozzarella, tomatoes and shaved parmigiana in a balsamic and lemon dressing. Daily specials augment the menu.


